## General Marking Guidance

- All candidates must receive the same treatment. Examiners must mark the first candidate in exactly the same way as they mark the last.

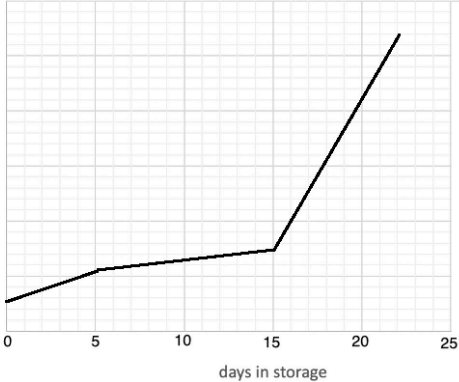

3(a)	<p>An answer that includes the following points :</p> <ul style="list-style-type: none"> <li>• serial dilution of stock solution / described (1)</li> <li>• describe method to measure out same volume of each dilution (into test tube) (1)</li> <li>• add same {volume / no. of drops} (of same concentration) iodine (solution to each test tube) (1)</li> <li>• description of method for observing colour of solution (1)</li> <li>• {observe / note down} the colour of the resultant solution (1)</li> </ul>	<p>e.g. putting solution in a test tube of the same diameter</p>	(4)

3(b)	<p>An answer that includes the following points:</p> <ul style="list-style-type: none"> <li>• Russet <b>and</b> King Edward show {high(er) level of starch / black and dark blue} <b>and</b> therefore best for baking (1)</li> <li>• Nicola <b>and</b> Purple Congo show {low(er) level of starch / pale blue } <b>and</b> therefore best for boiling (1)</li> <li>• King Edward better than Russet for baking / Nicola better than Purple Congo for boiling / King Edward best for baking, Nicola best for boiling(1)</li> <li>• therefore the suggestions are supported by the data (1)</li> <li>• a comment on the subjectivity of the colour differences (1)</li> </ul>	e.g. the results are semi-quantitative	(4)
